

For over 50 years, Daily Planet Health Services (DPHS) has been a stable presence in the Greater Richmond Area, continually responsive to the community and agile in our approach to caring for Richmond's most vulnerable.

At our main locations, and through various community partnerships, we bring our unique integrated quality health services to those experiencing homelessness, those in unstable housing situations, and anyone regardless of their financial or insurance status.

Most recently, we have adapted our services to address the COVID-19 pandemic. Our purchase of 511 W. Grace St. allowed us to create a COVID-19 assessment center, where patients can be safely tested.

The rapid adaptation of telemedicine allowed our patients to continue to access care—especially important for those with opioid use disorders for whom consistent treatment is critical to their recovery.

Our impact in the community helps move us closer to our vision of a community where ALL are empowered to live healthy, enriched, and stable lives.




Highlights

- New York Times Best-selling Author Beth Macy discussed her book "Dopesick" which champions the use of Medication Assisted Treatment (MAT) to address opioid addiction. DPHS was an early adopter of MAT in Virginia and served 329 patients this year, up 106% from 2018.
- 1,023 patients were enrolled in Medicaid, increasing our patient coverage by 13%.
- Medical Respite served 138 individuals, helping over 77% stabilize their medical conditions.
- Safe Haven served 62 veterans and Ryan White Part B homeless individuals, with 65% moving to permanent housing.
- Dr. Patricia Cook joined as Chief Medical Officer, bringing with her a strong record of service with underserved populations and FQHCs.


